b. **Agreement with Milesplit**

This is a registration platform only, this is not a timing crew and will not replace Enduro or other timing companies, nor will it affect the OHStrack website. Rankings used for Regional assignments will be taken only from the rankings provided on OHS by Advisory Members and/ or OSSAA rankings. Current timing systems/ companies can be used, milesplit utilizes CSV format for data collection. No memberships are required, accounts are free to create.

Using MileSplit registration is extremely important in order to have a seamless postseason. We are not able to guarantee the best and most accurate seeds if a different platform is used.

You can use whatever timer you like but we strongly recommend using MileSplit for registration during the regular season and submitting the form that you're receiving from Alonso Rodriguez. If you would like a MileSplit compatible timer, MileSplit would be happy to provide a list. If you have not received a form but would like additional details on what you need to do, please reach out to alonso@flosports.tv.

This will also be practice for the postseason so that the first meet you're using this for isn't the postseason.
